## Happy New Year

### NATIONAL OFFERING GRANTS TO POSTS IN NEED!

At the 2020 Fall National Executive Committee Meeting, Resolution #36, Subject: Mission Blue Post Assistance Program was approved. Posts impacted by a government's public health restrictions implemented in response to the COVID-19 pandemic may apply for a grant up to \$1,000. Posts must meet the following eligibility criteria:

- A post must have a current consolidated post report on file.
- A post must have filed an IRS 990 within the prescribed due date.
- A post must have filed all other required forms and reports as prescribed by the departments.
- A post must have actively participated in one or more The American Legion(s) within the last 18 months.
- A post must have a financial need.
- A post must provide a certificate of insurance naming The American National Headquarters as an additional insured (copy of insurance declaration will be attached to application).
- A post must provide documentation indicating that the post is properly incorporated.

The funds from this grant program shall be used exclusively for the following:

- Current and past due mortgage principal and interest or
- Current and past due real estate rents or
- Current and past due insurance premiums or
- Current and past due utilities.

The American Legion posts receiving this grant are required to submit a true and accurate report outlining how the funds were used, signed by the post finance officer, and certified by the post commander or post adjutant within six-months of receipt of the grant funds or no later than February 22, 2022. Whichever comes first.

The enclosed application form with the instruction sheet provides more submission information and where to send the application upon completion.

## **\*\*IMPORTANT LIQUOR PERMIT UPDATE\*\***

- **Renewals of Club Permits Extended.** The Department of Consumer Protection shall extend all café liquor permits due to expire on or before February 8, 2021, that were club permits, non-profit club permits, or golf country club permits prior to the enactment of Public Act 19-24, such that they shall now expire on February 9, 2021.
- **Refund of Certain Renewal Fees.** The Department of Consumer Protection shall refund any permit renewal fee paid for a renewal effective between July 1, 2020 and February 8, 2021 by any café liquor permittee that was a club permittee, a non-profit club permittee, or golf country club permittee prior to the July 1, 2020 effective date of Public Act 19-24.
- While this does fix the problem, it does give the legislature time to act on this during a normal session which will more than likely be in February 2021.

Deadline to return app to Department HQ is March 1<sup>st</sup>. Department winner receives \$1000.

## **DEPARTMENT CONVENTION SPECIAL JANUARY 1, 2021**

Your attention is called to the following two (2) Constitutional Amendments adopted by the 1949 Department Convention.

Posts are hereby notified that any Constitutional Amendments or Resolutions, binding as American Legion Policy upon the Department or its Posts, **MUST BE SUBMITTED** at least sixty (60) days prior to the opening of the Department Convention... MAY 7, 2021 to Department Headquarters. Department Headquarters will furnish the required electronic form to any Post or individual upon request.

### **CONSTITUTION**

#### **ARTICLE XII**

Section 1. This constitution may be amended at any Department Convention by the vote of two-thirds of the total authorized representation thereat, provided that the proposed amendment shall have been presented in writing to the Department Executive Committee at least sixty days before the opening of the Convention and a copy thereof transmitted to each Post at least thirty (30) days prior to such convention.

### **By-Laws**

#### **ARTICLE VII**

Section 8. Any resolution which it is proposed to submit to the Department Convention, shall, if after passage, be binding as American Legion policy upon the Department or its constituent Posts, be presented in writing to the Department Executive Committee at least sixty (60) days before the opening of the convention and the Department Adjutant shall transmit a copy to each post at least thirty (30) days prior to such convention.

# American Legion Department of Connecticut National/Homeland Security & Disaster Relief January 2021 Newsletter

## The American Legion's National Security Policy

The American Legion believes national security must be maintained to fulfill the mandate for a strong national defense. As stated in the Preamble, "FOR GOD AND COUNTRY WE ASSOCIATE OURSELVES TOGETHER FOR THE FOLLOWING PURPOSES: To uphold and defend the Constitution of the United States of America... To safeguard and transmit to posterity the principles of justice, freedom and democracy."

The Legion is an organization of veterans who fought for freedoms, which they are dedicated to keeping and preserving. As one of the Four Pillars it was founded on, the Legion believes national security is upheld by keeping a well-funded Department of Defense, a good quality of life for troops and a sensible transition between service and separation.

## National Security News

The United States needs to build more bombers and upgrade its existing bombers and that means more defense spending. As *Air Force Magazine* reports, 62 B-1Bs (developed in the late 1970s/early 1980s), 76 B-52s (developed in the 1950s) and 20 B-2s (developed in the 1980s) comprise America's 158-plane bomber fleet (down from 411 bombers in 1990). The United States plans to field even fewer bombers next year (140), as the Air Force tries to shift resources into the B-21 Long Range Strike Bomber, which will not achieve initial operational capability until 2025.

Those dwindling numbers and aging airframes wouldn't be a concern if our enemies were beating their swords into plowshares. But with China on the rise, Russia on the march, the Middle East on fire, and our allies in Europe and the Pacific on edge, we know the very opposite to be true. In this environment, 158 bombers -- let alone 140 -- aren't nearly enough to deter our enemies and defend our interests. For the entire story visit: <https://www.legion.org/landingzone>

## Disaster Relief and Assistance

The American Legion Department of Connecticut National/Homeland Security and Disaster Relief Committee intends to establish a rapid response program for disaster relief. The program will be designed to immediately collect relief items such as bottle water, clothing, health care goods and similar items that may be need by victims immediately after a disaster. These items would be collected by participating American Legion Posts in Connecticut and delivered by Connecticut Legionaries to an American Legion Post in the area of the disaster for distribution to the public. ## Disaster Preparedness

The American Legion has formed a special entity to provide a forum for military veterans who today are engaged in a hobby that can also provide emergency communications "when all else fails." During the May 2011 Spring Meetings, the National Executive Committee authorized the establishment of The American Legion Amateur Radio Club (TALARC).

"The beauty of amateur radio is that it attracts folks of all career interests, from doctors, Ph.Ds., engineers, rocket scientists to mechanics, housewives, construction and office workers, students and everything in between," says Robert L. Morrill, chairman of the Legion's Public Relations Commission. "Hams provide backup communications to emergency-management agency offices across the country when 'all else fails,' and have done so with distinction in virtually every major disaster when cell towers and commercial communications have been knocked out after earthquakes, hurricanes, tornadoes, and man-made disasters."

## MISSION BLUE POST ASSISTANCE PROGRAM GRANT APPLICATION

#### INSTRUCTIONS & MISSION BLUE POST ASSISTANCE PROGRAM GRANT APPLICATION

**For assistance in completing this application, or for contact information, contact your department at [www.legion.org/departments](http://www.legion.org/departments).**

**POST GRANT (Application–Page 3):** The Mission Blue Post Assistance Program (PAP) grant is intended to assist posts whose revenue has been negatively impacted from the effects of the COVID-19 health crisis within the community, as well as any government-mandated restrictions. The funds distributed from this grant are to be exclusively used to meet financial responsibilities associated with maintaining post facilities and community presence. Grants are only approved to cover costs and fees associated with mortgage payments, rent, insurance premiums, and/or utilities. Recipient posts are prohibited from using funds to maintain or cover a loss of income from any registered post business (including but not limited to post bars, cantinas, restaurants, etc.) paying post employees, building upgrades or repairs, taxes, fines/fees/penalties, or funding post activities and programs. Posts who meet all the required criteria may receive up to \$1,000.00 from the Mission Blue PAP fund. Department commanders/adjutants are encouraged to complete a Mission Blue PAP grant application on behalf of the post.

**QUALIFYING CRITERIA:** American Legion posts who meet all qualifying criteria for the Mission Blue PAP Grant are eligible to receive up to \$1,000.00. Department commanders/adjutants must certify the applicant post meets the following criteria:

- Must have a consolidated post report on file.
- Must have filed an IRS 990 within the prescribed due date.
- Must have filed all other required forms and reports as prescribed by the department.
- Must have actively participated in one or more American Legion program(s) within the last 18 months.
- Must have a financial need.
- Must provide a certificate of insurance for all liability coverage naming The American Legion doing business as (dba) American Legion National Headquarters and the post's department as an additional insured.(Submit declaration page showing coverage)
- Must provide documentation indicating that the post is properly incorporated.

**REQUIRED APPLICATION INFORMATION (Application–Page 3):** Department leadership must verify that applicant posts meet all the qualifying criteria prior to submission of the grant application. Posts and departments do not need to submit any bills or receipts along with grant applications. The application must be filled out completely and accurately to prevent delay in processing. Grant requests may be submitted in fillable PDF format and sent via email to [IA@legion.org](mailto:IA@legion.org). Any questions regarding this grant should be directed to the Internal Affairs & Membership Division.

**APPROVAL SIGNATURE OF GRANT APPLICATIONS:** Upon review, if additional information is needed, the department will be contacted. If the application is properly completed and all qualifying criteria and requirements are met, the Internal Affairs & Membership Division will endorse the application and forward a request for funds to the Finance Division. After review and approval by the National Adjutant, a check will be issued and forwarded to the department headquarters to disburse to the applicant post along with a grant fulfillment letter which will also include reporting instructions.

If any of the above steps have not been taken, the application may be returned to the department headquarters for amendment or further clarification. Applications not approved will be returned to the department headquarters with reasons for disapproval who will then notify the applicant post.

**REPORTING REQUIREMENTS:** Posts are required to submit a true and accurate report outlining how the grant funds were used (mortgage, rent, insurance premiums, and/or utilities) within six months of the receipt of funds and no later than February 28, 2022. Information regarding the report format and submission will be included within the grant fulfillment letter. This report should be reviewed by department headquarters prior to forwarding it to the Internal Affairs & Membership Division at the national headquarters.



## MISSION BLUE POST ASSISTANCE PROGRAM GRANT APPLICATION

### ADDITIONAL INSTRUCTIONS

1. This form contains two sections: a post information section and a department verification section. Both sections must be completed in full. Departments will need to review the instructions and information within this document with the applicant post prior to completing the grant application.
2. Departments will need to obtain the necessary records to verify all qualifying criteria have been met. These are only for the department verification process and additional records do not need to be sent to national headquarters along with the application. If additional information is needed for the review process, the department will be contacted.

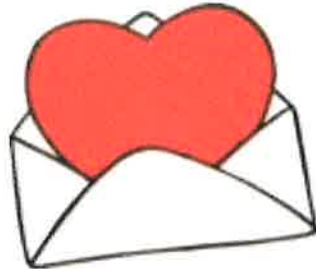
