With Activation of NATO Response Force, U.S. Military Ready to Provide Forces

In response to the Russian invasion of Ukraine, NATO Secretary General Jens Stoltenberg announced activation of the alliance's defense plans, which means also that it can deploy the NATO Defense Force. The U.S. Defense Department now stands ready to provide capabilities to help fill that defense force, if asked to do so, said Pentagon Press Secretary John F. Kirby.

"There's a historic nature to all this," Kirby told reporters during a briefing at the Pentagon today. "This is the first time that the alliance has employed these high readiness forces in a deterrence and defense role. So it's not an insignificant move by the alliance."

The activation serves as a notice to [NATO](#) nations that they may be called upon to provide military support to the NATO mission, Kirby said. This also means the United States may be called upon to provide both personnel and equipment to support the NATO mission — and that's something the U.S. and the department has been preparing to do for quite some time.

Kirby said what kinds of assistance NATO may request from the United States, or other alliance nations, is unknown at this time, as is what specific U.S. military units may end up being assigned to what roles.

Still, Kirby said, the U.S. has put as many as 12,000 service members on "prepare to deploy orders" so they will be ready if called upon to participate in the NATO Response Force. Some of those U.S. personnel may also be called upon to participate in any unilateral actions the U.S. may undertake.

"The department has placed a range of multi-mission units in the United States and Europe on a heightened preparedness to deploy, which increases our readiness to provide for the U.S. contributions to the NRF on a shorter tether than what we could do before," Kirby said. "We stand ready if called upon by NATO to support the NRF in the defense of the alliance, and will absolutely do that."

While President Biden has said U.S. troops will not enter Ukraine to participate directly in the fight against Russia, U.S. forces may eventually be called upon to participate in NATO-led missions as part of the NATO Response Force to bolster the defense of alliance partner nations should they ask for assistance. American Legion legislative victories and priorities for 2022

The American Legion's Internal Affairs & Membership Division held its monthly Training Tuesday session Jan. 25 where Legislative Division staff from the Washington, D.C., office discussed American Legion legislative victories for the first session of the 117th Congress, legislative priorities for the second session, and how Legionnaires can be a voice at the local level.

Legislative Division Director Lawrence Montreuil first highlighted American Legion legislative victories for 2021 that were passed in the FY 2022 National Defense Authorization Act.

LEGISLATIVE VICTORIES

The Global War on Terrorism Memorial to be built in a prominent location on the National Mall. In honor of the longest war in U.S. history and the more than 2.8 million American servicemembers who have been deployed abroad, the memorial will be built "in a place of prominence on the National Mall so veterans of the Global War on Terror can come and remember their service and remember those who never came home," Montreuil said. *Resolution No. 16, 2017*

The Protecting Moms Who Served Act aims to improve maternal health care for veterans, to include a \$15 million investment from the VA to upgrade maternity care for women veterans, and a first-ever comprehensive report on maternal mortality and severe maternal morbidity among pregnant and postpartum veterans that also focuses on racial and ethnic disparities in maternal health outcomes for veterans. "The women veteran population is the fastest serving demographic that the VA will serve in the coming years," Montreuil said, adding that there will be about 2.2 million women veterans by 2040. *American Legion Resolution No. 147, 2016*

The Sgt. Ketchum Rural Veterans' Mental Health Act will expand access to mental health care for rural veterans. The American Legion has worked with VA to introduce a pilot program that provides telehealth sites in American Legion posts to serve rural areas, known as Project ATLAS. *American Legion Resolution No. 75, 2017*

The American Rescue Plan, which closes the 90/10 loophole. This rule mandated for-profit schools to obtain at least 10 percent of their revenue from sources other than Title IV education funds, which are the primary source of student aid. *American Legion Resolution No. 15, 2019*

BILLS BEING TRACKED

American Legion Washington, D.C., staff are currently tracking hundreds of veteran-related bills in the second session of the 117th Congress that The American Legion supports. The following are a few of those bills.

Citizenship for service

– **H.R. 1182, Veteran Deportation Prevention and Reform Act** and Senate bill **Naturalization at Training Sites Act of 2021**. Many veteran immigrants say they have been deported after discharge because they failed to acquire U.S. citizenship while serving in the U.S. Armed Forces. The American Legion supports measures to ensure the process of naturalization through military service is completed prior to discharge.

Toxic exposure

– **H.R. 3967, Honoring Our PACT Act** and **S. 3003, True COST of War**. “There is a bipartisan agreement that action will be taken in some way to ensure that those veterans during the Global War on Terrorism and the Gulf War who were exposed to toxic airborne hazards are taken care of in a more proactive manner than we did with Agent Orange,” Montreuil said. These two bills will presume a veteran of the Global War on Terror was exposed to burn pits based on geographic location and time of service, or if they have a campaign badge or the Global War on Terrorism Expeditionary Medal. “This takes a huge weight off the individual veteran when they are applying for benefits because all they have to do is take their DD214 that lists their medals and you have presumption of exposure,” Montreuil added.

Mental health care

– **S.1198, Solid Start Act** will expand the VA Solid Start Program. Under this program, the VA is required to reach out three times in the first year that a servicemember is separated from the military.

– **S.544, Buddy Check** bill will require the Department of Veterans Affairs to establish a “Buddy Check Week,” similar to the Legion’s program, as well as provide educational opportunities, materials and references for veterans to learn how to conduct personal wellness checks. The language for this bill was included in a comprehensive veterans’ mental health bill called the Strong Veterans Act, which looks to be on the president’s desk by the middle to end of February, said Legislative Division Associate Olivia Babine. “The hope is that by the end of February that the Buddy Check bill will be signed into law.”

– **H.R. 1476, PFC Joseph P. Dwyer Peer Support Program Act** will require the VA to make grants available to eligible organizations for peer support programs for veterans.

– **S. 2386, Veteran Peer Specialist Act of 2021** will expand the peer specialist support program of the Department of Veterans Affairs.

Veterans health care

– **H.R. 5562** and **S. 1040** bills will expand eligibility for hospital care, medical services, and nursing home care from the VA to include veterans of World War II.

– **S. 1319, VA Quality Care Accountability and Transparency Act** will require the Department of Veterans Affairs to publish and regularly update information about staffing, patient wait times, and other information regarding the quality of care it provides on its Access to Care public website.

Women veterans

– **H.R. 4794 and S. 2533, Making Advances in Mammography and Medical Options (MAMMO) for Veterans Act** would require VA to improve breast imaging services to veterans that includes a three-year pilot program to provide tele-mammography services for veterans who live in states where VA does not offer breast imaging services.

“There is an increasing rate of many young women but particularly women veterans who are under the age of 35 who are testing positive for breast cancer as a result of toxic exposure from serving overseas on combat zones,” Babine said. “This will be an important women veteran issue that we will see for the remainder of 2022.”

Education

– **H.R. 1836, Guard and Reserve GI Bill Parity Act of 2021** bill “provides parity in GI Bill benefits for members of the National Guard and reserve who increasingly conduct similar training and missions as other servicemembers, but do not receive equal benefits.”

Veteran homelessness

– **S. 2172, Building Solutions for Veterans Experiencing Homelessness Act** will “cut the red tape” on grants provided by VA for organizations assisting veterans experiencing homelessness, as well as expand veterans’ access to critical resources that will help them from homelessness such as increased access to transportation, case management services, job training and better transitional housing for aging veterans.

“We will see a big victory in our fight against veteran homelessness if we can get this bill passed,” said John Kamin, a Legislative Division associate and grassroots coordinator.

John Douglas Monahan Jack “... He has made us all proud.”

Jack Monahan is married to Dianne and they have two grown children: Megan and Caitlin. He is an Army Veteran. He retired as a Major in 1995.

Jack joined The American Legion LaPlace-Champlin Post 18, Essex in 1995.

Jack served as the assistant Post 18 Finance Officer, assistant adjutant, a member of the Memorial Day Committee, youth program chairman, and Commander, a job he still holds today. He served as an oratorical contest judge at the 7th District and Department Contests. He was the Posts Centennial Website coordinator.

Jack is a 2001 National College graduate, a PUFL member, and a member of ANAVICUS.

Jack's mentors are Sheldon Parker, Rich Anderson, Bill Pomfret, Gerald Dierman, and Joe Jackson.

At Department Jack Monahan was hired as the Asst. Treasurer in 2000 and from 2006-14 Jack was the Treasurer and the Administrator of the S, S, & M Fund. He is a member of The American Legion Connecticut Foundation.

He was appointed to the National Finance Commission and Endowment Fund, 2007. And in 2009, He was on the National Commander's ad hoc Committee on American Legion Baseball. In 2016, he was appointed to represent The Legion as a Commissioner to the United States World War One Centennial Commission. His position with this World War 1 Commission has been extensive.

Since joining in 1995, Jack has been active at all financial levels of our organization. Our department treasurer, a member of the National Finance, and the National Endowment fund committees. Past National Commander Jake Comer noted the following, "...Since the day I recommended John for the (National) finance position in 2007 to the present, he has made us all proud."

Jacqueline Evonsion, An Advocate for Women Outreach Programs

Jackie Evonsion is an Air Force Veteran, who served from May 1964 to March 1966. She joined Mass. Post 456 in 1992 and transferred to New Hartford's Charles A Fixer Post 28 in 2001. Jackie is a dual member of the American Legion Auxiliary, unit 28.

Her Family..she has 4 daughters: Michelle, Danielle, Kauwela, and Pomaikai.

Jackie's mentors have been Art Melycher, Art St. John, and Joe Jackson.

she has held the following post leadership positions: Jr. Vice, Sr. Vice, Commander 2004-07 and Adjutant 2008-2022. Over time, she became involved with post activities, membership, the oratorical contest, Scouting, Boys and Girls State, Memorial, Veteran's, and New Hartford Days.

In 2007, she attended the Conn. American Legion College.

In 2008, she was the Dept. Assistant Sgt-At-Arms. Then the 6th District Finance Officer, Vice Commander, District Commander during two different terms 2009-12 and 2015-17. Followed by Dept Historian 2012-15 and 2017-19. In 2011, she became the Women's Outreach Coordinator and the American Legion Riders Director. Jackie has been an active member of Centennial, Legion Riders, Women's outreach, C & Y, and Personnel. She has been a participant in 7 Legacy Runs, a member of the Bantam Post 44 Veteran of the Month program, and in 2014 she became a life member of ANAVICUS.

All her life she has been an advocate for Children and youth Programs, Scouts, Women Outreach Programs, and ensuring that all women, who serve for at least one day, know they are veterans.

Manuel Rodrigues “(He) lights up a room when he enters...”

Manuel Rodrigues served honorably first for the U.S. Marine Corps: 1962-66 and then the U.S. Army: 1975-91. Manny married Edwina Menditto and they have a daughter: Jennifer Miller.

Manny is an Honorary Life member of Green-Chobot-Richardson, Coventry-Mansfield Post 52 for the last 24 years. Jack Lacek, Bud Colburn, and Steve Andrewson were his mentors.

He has been the Post Sgt-At-Arms, Historian, Senior Vice Commander, Post Commander 2006-12, and Service Officer. He helped start the SAL in 2004. Since 2014, he has been the Service Officer and Post Commander. He coordinates all the Memorial Day Programs and flyover. As the Post 52 Scout Chairman Manny started Scout Troop 65 to assist veterans with Memorial Day activities and be part of a growing community. He initiated the Legions Junior Shooting, air rifle program in Coventry.

He has assisted the American Legion Auxiliary and Unit 52 Christmas Shop program at Newington, Rocky Hill, and West Haven. And helped with Bingo at the Veterans Home and Hospital at Rocky Hill.

In the 4th District, he was the Finance Officer, Senior Vice Commander and Commander. District Commander 2011-13 and Department Executive Committee 2013-15. He has been the 4th District Scout Chairman and a member of the Finance Committee. Department: Manny has held: Assistant Sgt-At-Arms 2014-15, and a member of the Convention Committee, Boys Scouts, and Junior Shooting Director. In 2015 Manny was the Department Sgt-At-Arms for Commander Paul Spedaliere.

Ronald P. Coderre, past 4th District Commander noted “Manny is a positive person, who lights up a room when he enters. He’s an uplifting individual who possesses unbounded energy. He’s what I call, a real ‘people person.’”

Louie C. Robinson – A Blue Cap Legionnaire

Louie C. Robinson is married to Shirley. He is an Army Veteran and a 31 year Legionnaire. It could have been longer since he wasn’t allowed into the Post because he wore sneakers. With the help of Past Commander Johnny Moody, he joined James E. McKinney Post 142. Johnny Moody, Brook Benford, and Kenny Hester were early mentors. Lou went to his first meeting and immediately started asking questions. Emery Keaton suggested that Lou be the Finance Officer. To get Louie from asking questions, he was appointed to the Post Finance Committee. Right from the start, Lou took on a number of positions: Assistant Sgt-At-Arms, Asst Finance Officer, Junior Vice Commander, and Commander 6 times, including 2003 when the post was gutted and updated.

He was 1st District Commander in 2007-08, 2010-12 and Department Sr. Vice and then Dept. Commander in 2016-17. At Department, Lou has been the Director and/or Chairman to the following: Children and Youth, Americanism, and State Fund Commission. And he has served on Centennial, Constitution & Bylaws, Commander’s Advisory Board, Membership, Membership Task Force, Internal Affairs, and VA & R. It appears that Lou has been there for just about everyone. He has assisted the American Legion Auxiliary with their Christmas Shop program and has worked a number of Bingos at the Rocky Hill Veterans home. And he chairs the annual Post 142 Americanism program prior to the 1st District Meeting in February.

Ken Lewis noted that “When I started to go to the First District meetings Louie Robinson welcomed me... he made an effort to talk to me... Louie is one of the reasons I became an active Legionnaire... Ken noted that Louie was” a true Blue Cap Legionnaire.”

Vietnam Veterans Memorial Replica Wall and Mobile Education Center spreads healing legacy of The Wall and educates about the impact of the Vietnam War

Washington, D.C. – The Vietnam Veterans Memorial Fund (VVMF) has announced *The Wall That Heals* national tour schedule for 2022. *The Wall That Heals* exhibit includes a three-quarter scale replica of the Vietnam Veterans Memorial along with a mobile Education Center. The 27th season of *The Wall That Heals* will begin on March 24, 2022, in Bay St. Louis, Mississippi and visit 29 communities during the year. The traveling exhibit honors the more than three million Americans who served in the U.S. Armed Forces in the Vietnam War, and it bears the names of the 58,281 men and women who made the ultimate sacrifice in Vietnam.

“We are excited to announce that *The Wall That Heals* will be visiting 29 communities in 2022. We look forward to providing these communities with a healing experience for local veterans and their families and an educational experience for all visitors on the continuing impact of the Vietnam War on America,” said Jim Knotts, president and CEO of VVMF. “VVMF’s mission is to honor

and remember all those who served in the Vietnam War, and we are ready to work with our 2022 hosts to deliver a safe opportunity for thousands to experience the healing and educational aspects of the Vietnam Veterans Memorial in 2022.”

Each year, VVMF receives more applications to host the exhibit than can be accommodated. For the 2022 tour schedule, preferential consideration was given to cancelled sites from the 2020 tour that reapplied for 2022.

The Wall That Heals is generously sponsored by USAA. Through a partnership with the Truckload Carriers Association (TCA), the trucking industry, and Blue Beacon, the exhibit is able to travel across the country. Hosts in each community provide for the location, volunteers, and preparations necessary to replicate the experience a visitor would have at the Vietnam Veterans Memorial in Washington D.C.

VVMF will work closely with each community to maintain and exceed health and safety standards as established by the appropriate federal, state, and local authorities.

“Nothing is more important to VVMF than the health and well-being of our Vietnam veterans and their families. We will work to provide the best visitor experience while keeping the safety of our staff, volunteers and visitors at top of mind,” said Knotts.

Since its debut in 1996, the exhibit has been on display in nearly 700 U.S. communities in addition to an April 1999 tour of the Four Provinces of Ireland and a visit to Canada in 2005. *The Wall That Heals* is a program of VVMF, the nonprofit organization that built the Vietnam Veterans Memorial in Washington, D.C. in 1982. *The Wall That Heals* is the only traveling exhibit affiliated with The Wall in Washington, D.C. and includes the largest Wall replica that travels the country. Two VVMF staff members lead volunteers on site, educate visitors and students, and ensure the reflective atmosphere of The Wall. More information can be found at: www.thewallthatheals.org.

About The Wall replica

The three-quarter scale Wall replica is 375 feet in length and stands 7.5 feet high at its tallest point. With the replica at this size, visitors are able to experience The Wall rising above them as they walk towards the apex, a key feature of the design of The Wall in D.C.

Like the original Memorial, *The Wall That Heals* is erected in a chevron-shape and visitors are able to do name rubbings of individual service member's names on The Wall. The names are listed in order of date of casualty and alphabetically on each day. Beginning at the center/apex, the names start on the East Wall (right-hand side) working their way out to the end of that wing, picking up again at the far end of the West Wall (left-hand side) and working their way back in to the center/apex. The first and last casualties are side by side at the apex of the Memorial.

The replica is constructed of Avonite, a synthetic granite, and its 144 individual panels are supported by an aluminum frame. Modern LED lighting from the top of The Wall provides readability of The Wall at night.

About the mobile Education Center

The Wall That Heals is transported from community to community in a 53-foot trailer. When parked, the trailer opens with exhibits built into its sides, allowing it to serve as a mobile Education Center telling the story of the Vietnam War, The Wall, and the divisive era in American history.

The mobile Education Center exhibit includes: digital photo displays of “Hometown Heroes” – service members whose names are on The Wall that list their home of record within the area of a visit; digital photo displays of Vietnam veterans from the local area honored through VVMF’s *In Memory* program which honors veterans who returned home from Vietnam and later died as a result of their service; video displays that teach about the history and impact of The Wall; educational exhibits told through items representative of those left at The Wall in D.C.; a replica of the *In Memory* plaque; a map of Vietnam and a chronological overview of the Vietnam War. The exhibits tell the story of the Vietnam War, The Wall and the era surrounding the conflict, and are designed to put American experiences in Vietnam in a historical and cultural context.

About VVMF

The Vietnam Veterans Memorial Fund (VVMF) is the nonprofit organization that built the Vietnam Veterans Memorial (The Wall) in Washington, D.C. in 1982. VVMF continues to lead the way in paying tribute to our nation’s Vietnam veterans and their families. VVMF’s mission is to honor and preserve the legacy of service in America and educate all generations about the impact of the Vietnam War and era through programs, ceremonies, and education materials.
